

4a (Code:) (Expenses \$ 150,699 including grants of \$) (Revenue \$ 432,987) Our On-Point Restorative Mentor Circles are on site campuses in Pomona Unified School Dist. and Apple Valley Unified. We have contractual agreements with individual school in the school districts with services ranging from 2-5 days/wk, and 2-3 hrs/day depending on the needs of each school site. We also stay during lunch or recess time as a presence on-campus to engage students in informal settings. Our children and youth populations demonstrate high percentage of fatherlessness, high drop-out rates, high number of juvenile offenders, teen pregnancy and the like. Population of students i 44% are males and 56% are females, 80% are Spanish Speaking-limited English. This program on campuses focusing on developing trust in smal circles, and instruction through our own curriculum developed to address the needs of our youth. Program expenses includes program supplies and salaries for staff.

4b (Code:) (Expenses \$ 885 including grants of \$) (Revenue \$) Mentor/Connect Night Program serves as a support program to our youth and links them between school and their community on Thursday nights and occasionally on a weekend event. We serve to connect youth to mentors based on interests, abilities, affability, etc. to inspire and motivate students in their own journey toward a successful navigation of childhood and teen years, supported by healthy adults in their lives, cheering them on, guiding them, to be the best self and eventually contribute to the well-being of their community. The program served 112 youth during the year for more than one night, totaling approximately 450 contacts per year. (50 youth x 30 mentor nights). The connect part of this program defines specific interests of the students and seeks to connect them to like-minded individuals. These smaller groups meet with volunteers or staff with specific talents/ability interests. This program in no more than 15 students per night to develop even smaller ratio of student to volunteer and develop those meaningful contacts This program does not generate income of any sort.

4c (Code:) (Expenses \$ 297,851 including grants of \$) (Revenue \$ 583,852) KEEP PROGRAM is hybrid, restorative tutoring program in addition to On-Point program. It supports distance learning and traditional model. Tutors provide restorative services to students in need of academic support, mentoring and tutoring. We employ a couple of staff on a part time basis, who serve on circles during school hours, but are available after school to provide this service. (expenditures include payment of tutors.)
